Legislative Updates

January 14th kicked off the 2025 legislative session for Minnesota. This year's session was set to be a unique year with the 2024 election resulting in both the House and the Senate having a tie between Republican and Democratic legislators.

As session began, several special elections were needed due to a Senator passing away and challenges to two House members due to missing ballots and a question on residency of an elected House member within the district elected. Also, the Governor's budget was released with major concerns to the direction of Health and Human Services.

The House of Representatives had it's own share of concerns and issues with members boycotting the session due to a shared power agreement no longer being recognized, the two special elections and the uncertainty of when those special elections would take place and Minnesotans frustrated with delaying progress. As of now, all are back to work at the capitol and hearing are taking place.

To view the Governor's budget, please clickhere. While the Governor's budget is a recommendation and a guide for the state legislature not all items are definite. You can take action and connect with your legislators to share concerns or support. Here is how you find your legislator by checking out Who Represents Me. The website, Who Represents Me is a great tool to view both your local and federal legislators just by entering your zip code. You will be able to connect with your legislators, find their contact information and the committees they serve in.

Another option for staying involved is to view both <u>House and Senate</u> <u>hearings</u> from you own home since it is not always easy to travel up to the capitol. Each day a schedule is put out with the committee hearings, the bills that will be heard and the time the hearing will take place.

MRCI is keeping a close eye on this year's legislative session and bills being proposed to make sure the families we serve are well informed and you or your loved ones services are not affected. MRCI will continue to keep everyone up to date with newsletter updates, Action Alerts for items that could pose a risk to services, and ways you can assist to avoid program changes, waiver reimagine, or cuts to health and human services.

A reminder to those who are eligible for Sick and Safe leave as part of Minnesota State Statute. Sick and Safe time can be used for multiple reasons including:

- Employees or employee's family members mental or physical illness, treatment or preventive care;
- If injury of employee or employee's immediate family* occurs;
- Absence due to domestic abuse, sexual assault or stalking of the employee or a family member;
- If public emergency arises.

<u>Sick and Safe leave cannot be cashed out</u>. Sick and Safe accumulated balances are included on your pay statement.

*Immediate family is defined as: child, adult child, foster child, spouse, sibling, parent, mother-in-law, father-in-law, grandchild, grandparent, or stepparent.

2025 Training Schedule

Each year MRCI is required to assign training to all workers under the 245D programs of **Individualized Home Supports (IHS)**, **Respite**, **Host Home**, **Night Supervision**, **and Homemaker**. Below is the calendar of when the training will be assigned.

Training is assigned in the beginning of the month and is due by the last day of the month. If your worker does not complete the training they will be temporarily suspended and **not able to clock in or out** through the app, or be paid for the time worked until complete.


